

# **Casework and Advocacy Coordinator**

# Job Description

## The role:

As the Casework and Advocacy Coordinator you will manage individual cases of protection and family reunification, whilst improving referral pathways in the North of France and the surrounding areas. Through information-sharing and advocacy, you will ensure that unaccompanied minors and people in vulnerable circumstances can access safe and legal routes to sanctuary. You will work in partnership with field organisations to develop an advocacy strategy to promote legal pathways in the post-Brexit context. This is a cross-border role, requiring strong teamwork with colleagues based in Paris, Athens and London.

- Salary 29,000 euros (dependent on experience)
- Permanent, full-time
- Safe Passage France
- Based in Paris with trips to Northern France and occasional trips to the Safe Passage Head Office in London / or based in North of France with occasional trips to Paris office and to the Safe Passage Head Office in London
- Reporting to Head of Safe Passage in France

### Key responsibilities:

- Manage casework for individual cases of family reunification from France to the UK. This includes responding to enquiries of beneficiaries and their family members, providing information, liaising with social services and the authorities, collecting evidence, helping to access asylum and keeping thorough records of all interactions.
- Manage casework for individual cases of family reunification to France.
- Collect information for advocacy purposes, to identify advocacy opportunities and to set up advocacy actions emulation to the Brexit.
- Develop and maintain relationships with protection service providers, legal representatives, local authorities, and NGOs in the Nord Pas de Calais.
- Adhere to Safe Passage Safeguarding policies and procedures at all times.

Safe Passage was founded in late 2015 in response to the thousands of refugees living in precarious conditions in the "slums" of Calais. Since then we have grown from a small UK project, to an international organisation with 24 members of staff supporting refugees to access safe and legal routes to asylum across Europe. We are a cross border organisation with offices in the UK, France and Greece.

- We do things differently championing refugee rights through strategic legal work, advocacy, capacity building and community organising.
