As the transformation of societies is first and foremost the responsibility of local players, its activities aim to strengthen their capacity for action and influence.

FIDH federates nearly 200 national human rights associations active in over 115 countries. FIDH is headquartered in Paris. The International Secretariat teams are present in Africa, Latin America, Asia and Europe. They are structured into an Operations and Programs Department and an Advocacy Department, as well as Support Departments (Communications, Finance and Administration, Partnerships and Development, Human Resources).

Terms of reference

On June 26, 2014, the Human Rights Council adopted Resolution 26/9, which established an openended intergovernmental working group (OEIGWG) to address the role of transnational corporations and other business enterprises concerning human rights. The group's primary mandate is to draft a legally binding instrument (LBI) to regulate corporate activities under international human rights law.

Despite the adoption of the UN Guiding Principles on Business and Human Rights (UNGPs) in 2011, victims of corporate abuses still face significant barriers to justice. Corporate operations continue to result in widespread human rights and environmental violations, often with limited accountability.

While progress has been made through national and regional initiatives, these measures remain insufficient to address the global scope of the issue. Emerging due diligence legislations, though promising, frequently fall short of their intended impact. The LBI represents the most robust and broadly-supported international framework for ensuring corporate accountability.

Since the adoption of Resolution 26/9, ten negotiation sessions have been held in Geneva, involving over 100 states, numerous experts, and hundreds of civil society organizations (CSOs), including FIDH and its member organizations. However, the <u>Updated Draft</u> published in 2023 contains many contentious elements. While there have been some positive developments, the Updated Draft is seen as a regression in efforts to establish a robust and protective treaty regulating corporations. In the framework of the 10th session, FIDH outlined its <u>detailed position</u> on the Updated Draft.

At its 56th session in July 2024, the Human Rights Council adopted <u>decision 56/116</u> in order to enhance the OEIGWG's support capabilities. Starting in 2025, and for a period of three years, the OEIGWG will be authorised to hold up to 10 intersessional thematic consultations annually. These <u>intersessional consultations</u> will aim to discuss clusters of articles of the instrument that is currently being negotiated, i.e., articles 4 to 11, in the view of building consensus among States and accelerating the negotiation process ahead of the 11th session. Held in person in Geneva, the consultations will provide opportunities for States and non-state actors to comment on the clustered articles through informal statements and to ask clarifying questions to the legal experts who were selected last summer by the Chair-Rapporteur.

Specific objectives of the consultancy

- 1. Advocate for an ambitious treaty based on FIDH's legal analysis of the Updated Draft.
- 2. Encourage States to contribute constructively to the informal thematic consultations and to the 11th session of negotiations.
- 3. Refine FIDH's legal position on key contentious elements of the Updated Draft following the 10th session and the intersessional consultations.
- 4. Contribute to the collective advocacy efforts by other civil society organisations and networks such as ESCR-Net, Feminists for a Binding Treaty, and the International and European Treaty Alliance of which FIDH is a member.

Key activities

- Participation in the informal thematic consultations in Geneva;
- Preparation and delivery of key recommendations during these consultations based on FIDH's legal analysis of the Updated Draft;
- Targeted advocacy with Member States on key legal issues;
- Engagement with the strategic and coordination efforts by civil society coalitions on the treaty process;

- Preparation and publication of an updated FIDH position note ahead of the 11th session, if relevant;
- Participation in the 11th session.

The selected candidate may also be working on a second project related to the accession of Peru to the OECD.
